*A book entry with an **author** and an **editor**.*

*A book entry with an **author** and an **editor** as well as a **series** field.*

*An **incollection** entry with a **series** and a **number**. Note the format of the printed name and compare the **useprefix** option in the **options** field. Also note the **indextitle**, and **indexsorttitle** fields.*
- Cicero, Marcus Tullius: De natura deorum. Über das Wesen der Götter, Latin and German, ed. and trans. by Ursula Blank-Sangmeister, with an afterw. by Klaus Thraede, Stuttgart 1995.
*A bilingual edition of Cicero's De natura deorum, with a German translation. Note the format of the **language** field in the database file, the concatenation of the **editor** and **translator** fields, and the **afterword** field.*
- CTAN. The Comprehensive T_EX Archive Network, 2006, URL: <http://www.ctan.org> (visited on 01/10/2006).
*This is an **online** entry. The URL, which is given in the **url** field, is transformed into a clickable link if **hyperref** support has been enabled. Note the format of the **urldate** field (**yyyy-mm-dd**) in the database file. Also note the **label** field which may be used as a fallback by citation styles which need an **author** and/or a **year**.*
- Duggan, Anne J.: The Lorrão transcription of Benedict of Peterborough's *Liber miraculorum beati Thome*: Lisbon, Cod. Alcobaça CCXC/143, in: Scriptorium 51.1 (1997), pp. 51–68.
*A typical **article** entry. Note the field **number**.*
- The New Encyclopædia Britannica, ed. by Warren E. Preece, 15th ed., 32 vols., Chicago, Ill. 2003.
*This is a **collection** entry for an encyclopedia. Note the **useeditor** option in the **options** field as well as the **sorttitle** field. We want this entry to be cited and alphabetized by title even though there is an editor. In addition to that, we want the title to be alphabetized under “E” rather than “T”. Also note the **label** field which is provided for author-year citation styles.*
- Enzensberger, Horst: art. ‘Capo Colonne, Schlacht v.’, in: Lexikon des Mittelalters 2 (1983), col. 1484.
*An article in a work of reference (e.g. in an encyclopedia or in a dictionary), thus a typical **inreference** entry. Note also the fields **xref**, **pagination** and **bookpagination**.*
- Geer, Ingrid de: Earl, Saint, Bishop, Skald – and Music. The Orkney Earldom of the Twelfth Century. A Musicological Study, PhD thesis, Uppsala: Uppsala Universitet, 1985.
*This is a typical **thesis** entry for a PhD thesis. Note the **type** field in the database file which uses a localization key.*
- Giese, Martina (ed.): Die Annales Quedlinburgenses (MGH. Scriptores rerum Germanicarum in usum scholarum separatim editi 72), Hannover 2004.
*A **collection** entry. Note the **shorthand** field and compare the List of Shorthands. Not also the **citedas** option in the **options** field.*
- Gregor der Große: Régle pastorale, ed. by Floribert Rommel, trans. by Charles Morel, with a comment. by Bruno Judic, with an intro. by Bruno Judic, 2 vols. (Sources chrétiennes 381), Paris 1992.
*The edition of an early medieval text with an **editor**, a **translator** and a **commentator** who also wrote an **introduction**. Note also the **options** field.*
- Homer: Die Ilias, trans. by Wolfgang Schadewaldt, with an intro. by Joachim Latacz, 3rd ed., Düsseldorf and Zürich 2004.

- A German translation of the Iliad. Note the **translator** and **introduction** fields and the format of the **location** field in the database file. Also note the **sorttitle** and **indextitle** fields.*
- Jaffé, Philipp (ed.): Regesta Pontificum Romanorum ab condita ecclesia ad annum post Christum natum MCXCVIII, red. by Samuel Loewenfeld, Ferdinand Kaltenbrunner and Paul Ewald, 2nd ed., 2 vols., Leipzig 1885–1888.
Library: Shelfmark.
*A **collection** entry with **edition** and **volumes** fields. Note the **editora**, **editoratype** and **library** fields.*
- Judic, Bruno: Introduction, in: Gregor der Große: Règle pastorale, ed. by Floribert Rommel, trans. by Charles Morel, with a comment. by Bruno Judic, vol. 1 (Sources chrétiennes 381), Paris 1992, pp. 15–111.
*The introduction to an edition of an early medieval text. The edition features an **editor**, a **translator** and a **commentator**. Note also the option **oldbookauthor** inside the **options** field.*
- Kant, Immanuel: Kritik der praktischen Vernunft, in: idem: Kants Werke. Akademie Textausgabe, vol. 5: Kritik der praktischen Vernunft. Kritik der Urtheilskraft, Berlin 1968, pp. 1–163.
*An edition of Kant's Collected Works, volume five. This is an **inbook** entry which explicitly refers to the Critique of Practical Reason only, not to the entire fifth volume. Note the **author** and **bookauthor** fields in the database file. By default, the **bookauthor** is omitted if the values of the **author** and **bookauthor** fields are identical.*
- Idem: Kritik der Urtheilskraft, in: idem: Kants Werke. Akademie Textausgabe, vol. 5: Kritik der praktischen Vernunft. Kritik der Urtheilskraft, Berlin 1968, pp. 165–485.
*An edition of Kant's Collected Works, volume five. This is an **inbook** entry which explicitly refers to the Critique of Judgment only, not to the entire fifth volume.*

*A **review** entry. Note the **xref** field.*

*A **reference** entry. This entry type is meant for works of reference, e.g. encyclopedias or dictionaries. Internally, it is just an alias for a **collection** entry. Note also the field **options**.*

*A **book** entry. Note the **origdate** and **origlocation** fields and the “reprint” output.*
- Nietzsche, Friedrich: Sämtliche Werke. Kritische Studienausgabe, ed. by Giorgio Colli and Mazzino Montinari, 2nd ed., 15 vols., München, Berlin and New York 1988.
*The critical edition of Nietzsche's works. This is a **book** entry referring to a 15-volume work as a whole. Note the **volumes** field and the format of the **publisher***

and **location** fields in the database file. Also note the **sorttitle** and **sortyear** fields which are used to fine-tune the sorting order of the bibliography. We want this item listed first in the bibliography.

Nietzsche, Friedrich: Sämtliche Werke. Kritische Studienausgabe, vol. 1: Die Geburt der Tragödie. Unzeitgemäße Betrachtungen I–IV. Nachgelassene Schriften 1870–1973, ed. by Giorgio Colli and Mazzino Montinari, 2nd ed., München, Berlin and New York 1988.

*A single volume from the critical edition of Nietzsche's works. This **book** entry explicitly refers to the first volume only. Note the **title** and **maintitle** fields. Also note the **sorttitle** and **sortyear** fields. We want this entry to be listed after the entry referring to the entire edition.*

Idem: Unzeitgemäße Betrachtungen. Zweites Stück. Vom Nutzen und Nachtheil der Historie für das Leben, in: idem: Sämtliche Werke. Kritische Studienausgabe, vol. 1: Die Geburt der Tragödie. Unzeitgemäße Betrachtungen I–IV. Nachgelassene Schriften 1870–1973, ed. by Giorgio Colli and Mazzino Montinari, München, Berlin and New York 1988, pp. 243–334.

*A single essay from the critical edition of Nietzsche's works. This **inbook** entry explicitly refers to an essay found in the first volume. Note the **title**, **booktitle**, and **maintitle** fields. Also note the **sorttitle** and **sortyear** fields. We want this entry to be listed after the entry referring to the entire first volume.*

Springer, Otto: Mediaeval Pilgrim Routes from Scandinavia to Rome, in: Mediaeval Studies 12 (1950).

*A plain **article** entry. Note the field **shortjournal**.*

Vázquez de Parga, Luis, José María Lacarra and Juan Uría Rúa: Las Peregrinaciones a Santiago de Compostela, 3 vols., Ed. facs. de la realizada en 1948–49, Pamplona 1993.

*A multivolume book cited as a whole. This is a **book** entry with **volumes**, **note**, **sorttitle**, and **indextitle** fields.*

Wulfstan of York: The homilies of Wulfstan, ed. by Dorothy Bethurum, Oxford 1957, repr. London 1998.

*An edition of homilies by one medieval author. Note the **options** field as well as the fields **isbn**, **origlocation** and **origdate**.*
